## Volunteers Needed: Help Fix the Trails

We are trying to get our 12 miles of trails in shape for the season and are seeking 75 volunteers to help clear brush, smooth walkways and more. Most of the heavy equipment work will be done earlier, so this will be just slightly more strenuous than the fabled walk in a park.

## Deer Damage and Hunting at the Park

Hunting has always been allowed at Salt Springs Park, and we are considering joining a deer management program that will allow hunters to take more deer.

We have a forest management plan that says we should consider protecting part of the forest by reducing the number of deer that browse on young growth. The issue prompted considerable debate among directors of the Friends of Salt Springs Park, which manages the 842-acre park.

The Commonwealth of Pennsylvania controls any decisions about hunting on the 405-acre part of the park it owns. It allows hunting and deer-management permits at many of its other state parks.

The forest management plan we have concerns a section of a 137-acre parcel, although it is probable there is deer damage throughout the entire park. There is some sentiment that an increased deer kill would not actually protect the young growth, because hunting is prohibited in nearby lands and that deer from those lands would just replace those taken from park land. On the other hand, there is evidence of a reduction in deer damage when hunting was allowed in some non-park areas that were formerly islands of deer safety.

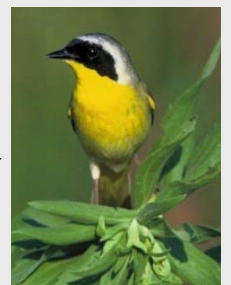
